

# 2019 PAYMENT POLICY

## CAMP EMERSON, SCOUTS BSA SUMMER CAMP | CAMP EMERSON, FAMILY CAMP

**Cancellation Policy:** All payments are non-refundable, and you will forfeit the money paid on spots/registrations dropped during any portion of the payment schedule. Payment is based on the number of campers, not named individuals. If you have a youth or adult who is fully paid but then cannot come to camp, we urge your unit to find a replacement for this person(s). Payments for cancelled spots are not credited to the unit balance if unit numbers are reduced.

### CAMP EMERSON, Scouts BSA

- 1) **\$200 deposit per unit is required at the time of making a reservation.** This deposit is non-refundable but applied to your final total.
- 2) First payment of \$100 per person is due no later than **Friday, January 31, 2020.**

**POPCORN CERTIFICATE USE:** Submitted no later than **Friday, January 31, 2020.**

- 3) Second payment of \$100 per person is due no later than **Friday, February 28, 2020.**
- 4) Third payment of \$100 per person is due no later than **Friday, March 27, 2020.**

**BONUS:** All payments paid on time and balance is paid in full by **Friday, March 27, 2020** receive **FREE** Summer Camp T-Shirt!

*(FREE T-Shirts will be provided to the number of campers registered and Paid in full on 3/27/20)*

- 5) **Total Balance is due** no later than **Thursday, April 30, 2020.**
- 6) Registrations received after **Thursday, April 30, 2020** are required to be paid in full at the time of registration.

### FAMILY CAMP

- 1) **\$200 deposit per unit is required at the time of making a reservation.** This deposit is non-refundable but applied to your final total.

**POPCORN CERTIFICATE USE:** Submitted no later than **Friday, February 28, 2020.**

- 2) First payment of \$100 per person is due no later than **Friday, March 27, 2020.**

**BONUS:** All payments paid on time and balance is paid in full by **Friday, March 27, 2020** receive **FREE** Family Camp T-Shirt!

*(FREE T-Shirts will be provided to the number of campers registered and Paid in full on 3/27/20)*

- 3) **Total Balance is due** no later than **Thursday, April 30, 2020.**
- 4) Registrations received after **Thursday, April 30, 2020** are required to be paid in full at the time of registration.

**NOTE:** All changes in camper numbers must be submitted in writing prior to the payment due dates from the contact person provided on the current reservation (email, mail, or in person) to Jessica Parker, Reservation Specialist [jessica.parker@scouting.org](mailto:jessica.parker@scouting.org). In the event of a unit's camper numbers changing (lower number of campers) after a payment due date, the unit is responsible for paying the cost (outlined above) of registered campers at the time of the scheduled payment date.
