After becoming an Eagle Scout, you may earn Palms by completing the following requirements:

1. Be active in your troop and patrol for at least three months after becoming an Eagle Scout or after award of last Palm.\*\*

2. Since earning the Eagle Scout rank or your last Eagle Palm, demonstrate Scout Spirit by living the Scout Oath and Scout Law.

3. Make a satisfactory effort to develop and demonstrate leadership ability.

4. Earn five additional merit badges beyond those required for Eagle or last Palm.\*\*\*

You may wear only the proper combination of Palms for the number of merit badges you earned beyond the rank of Eagle. The Bronze Palm represents five merit badges, the Gold Palm 10, and the Silver Palm 15.

**NOTES:**

- \* For Varsity Scouts working on Boy Scout requirements, replace “troop” with “team” and “Scoutmaster” with “Varsity Scout Coach.”
- For Venturers working on Boy Scout requirements, replace “troop” with “crew” and “Scoutmaster” with “Crew Advisor.”
- For Sea Scouts working on Boy Scout requirements, replace “troop” with “ship” and “Scoutmaster” with “Skipper.”
- \*\* Eagle Palms must be earned in sequence, and the three-month tenure requirement must be observed for each Palm.
- \*\*\* Merit badges earned any time since becoming a Boy Scout may be used to meet this requirement.

**EACH of the 6 requirements shown above, must be met for EACH Eagle Palm.**

**The Board of Review for the first Bronze Palm may be held no earlier than 3 months after the date of the Eagle Scout Board of Review.**

**The Board of Review for the first Gold Palm may be held no earlier than 3 months after the date of the Board of Review for the first Bronze Palm.**

**The Board of Review for the first Silver Palm may be held no earlier than 3 months after the date of the Board of Review for the first Gold Palm.**

**The Board of Review for the second Bronze Palm may be held no earlier than 3 months after the date of the Board of Review for the first Silver Palm., etc.**

**The “3 Month period mentioned in requirement 1 should be counted from the date of the preceding Board of Review, to the same date in the third month following, regardless of the number of days in each of those months. A 3 month period can thus range from 89 to 92 days.**

**Important excerpts from the [Guide To Advancement - 2015](#), No. 33088 (SKU-620573)**

**[1.0.0.0] — Introduction**

The current edition of the Guide to Advancement is the official source for administering advancement in all Boy Scouts of America programs: Cub Scouting, Boy Scouting, Varsity Scouting, Venturing, and Sea Scouts. It replaces any previous BSA advancement manuals and previous editions of the Guide to Advancement.

**[Page 2, and 5.0.1.4] — Policy on Unauthorized Changes to Advancement Program**

No council, committee, district, unit, or individual has the authority to add to, or subtract from, advancement requirements. There are limited exceptions relating only to youth members with special needs. For details see section 10, “Advancement for Members With Special Needs”.

**[Page 2] — The “Guide to Safe Scouting” Applies**

Policies and procedures outlined in the Guide to Safe Scouting, No. 34416, apply to all BSA activities, including those related to advancement and Eagle Scout service projects.

**[9.0.3.0] — About Eagle Palms**

Scouts or qualified Venturers and Sea Scouts may earn Palms after they have achieved the Eagle Scout rank. The requirements can be found in the Boy Scout Requirements book. All of the requirements except the board of review must be completed before age 18, and time extensions are not available. Merit badges earned at any time since becoming a Scout may be used. Palms must be earned in sequence, one at a time (Bronze, Gold, Silver), with the time requirement observed for each one. Palms are not considered ranks, but rather degrees of the Eagle Scout rank.
